## **East Harptree Community Benefit Society Limited**

### Motion 1

The Management Committee are recommending that:

East Harptree Community Benefit Society Limited members agree that under section 84 of the Co-operative and Community Benefit Societies Act 2014 by resolution they should disapply section 83 of the act (duty to appoint auditors) in respect of financial year ending 30 September 2025 as the total value of EHCBS assets at the end of the preceding year of accounts did not exceed £5,100,000, and the turnover for that preceding year did not exceed £10,200,000.

#### **Motion 2**

The Management Committee are recommending that the East Harptree Community Benefit Society Limited members agree that rule 4.12 be amended to:

Before a Members' Meeting can do business, a minimum number of Members (a quorum) must be present. Except where these Rules say otherwise a quorum is present if 20 Members or 10% of the Members entitled to vote at the meeting (whichever is lower) are present in person.

### Note 1

Under the rules of the Society the founding management committee must stand down at the first AGM and seek election. There are a number of spaces on the management committee and we welcome applications from potential members.

All positions on the Management Committee are open to members of the Society. It is hoped that enough members will come forward to fill the vacancies such that the Management Committee is as representative of the Community as is possible.
